# **Privacy Practices and Terms of Service**

#### 1. Information We Collect

As part of providing psychiatric care, we may collect the following personal information:

- Patient information: name, date of birth, address, phone number, email address, insurance details, and medical/psychiatric history.
- **Communication preferences:** including your choice to opt-in for SMS/text messaging.
- **Usage data:** information related to how you interact with our website, forms, and communication services.

#### 2. How Your Information is Used

We use the information we collect to:

- Provide psychiatric treatment and care.
- Schedule and manage appointments.
- Communicate regarding treatment, care updates, and administrative matters.
- Send informational, conversational, or promotional messages only if you provide explicit consent.
- Comply with legal, regulatory, and professional requirements.

## 3. Sharing of Information

- We do not sell, rent, or share your personal or medical information with third parties
  except as required by law or to coordinate your care with other providers when
  necessary.
- No mobile opt-in or text message consent will be shared with third parties or affiliates.
- Any third-party service providers engaged (such as secure messaging platforms) must comply with HIPAA and maintain strict privacy safeguards.
